I received a message from a family member, who asked me to call them regarding their veteran brother. I get these requests quite often and look forward to providing assistance. After calling, I was connected with a sister who was extremely distraught. Her younger brother, an Iraq and Afghanistan combat veteran was having a rough time. She told me he had been involved in three separate IED explosions during his multiple deployments. Although, he had no physical injuries, his posttraumatic stress was extreme and just riding in a car, on Route 13, caused flashbacks. She added, how he's underemployed because his occupational specialty (disarming bombs) did not translate into civilian jobs. In addition, he began self-medicating to dull his pain. At first it was alcohol and then she disclosed that he is using heroin. We spoke about his service to our country and how she blamed herself for his issues, because she encouraged him to join the military. I provided multiple behavioral health, substance misuse, and employment interventions ensuring she had specific points of contacts and not generic phone numbers. Because of her caring, I know this veteran is on his way toward cleaner living and focused therapy. This story highlights the serious issues facing our veterans. I am asking you become familiar with veteran resources to (behavioral health, substance misuse treatment, suicide, homelessness, employment) so that you can help. We all respect veterans' service to our nation, regardless of era, and must do what we can to eliminate their demons. Our agency will continue to help all veterans and with your input, we can make a positive difference in their lives.

John R. Knotts of Davis, CA, formerly of Dover, passed away on April 16, 2019. John was drafted into the U.S. Army during the Vietnam war. He eventually served 22 years in the armed forces, retiring from the U.S. Navy in 1999. John completed his Master of Business Administration at Charleston Southern University while serving in the Navy as a hospital administrator. He retired again in 2014 as the Executive Director of the State of Delaware Commission of Veterans Affairs. John was a dedicated public servant and friend to all. He loved sailing, golf, good conversation, and spending time with friends and family. John is survived by his wife, Dianne; daughter, Tiffany; son -in-law; granddaughter; sister, Nancy, and nieces and nephews. John was placed to rest in the Sacramento Valley National Cemetery in Dixon, Calif. on June 10, 2019.

John was born and raised in Dover. He graduated from Dover High in 1970. John began his career with the Commission of Veterans Affairs as the Senior Accountant in 2001. In addition to his regular duties, he was responsible for procuring several grants for the Veterans Memorial Cemeteries and instrumental in the design process and logistical requirements for the Delaware Veterans Home. He served as the Executive Director of the Commission from 2013-2014 and was well known for his dedication to Delaware veterans. In 1959, John's grandmother, Susie Roberts Knotts, donated 59+ acres of land to the State of Delaware for the Veterans Memorial Cemetery located in Bear.

John was a Life Member of Delaware Veterans Post 2 in Dover (Life members have to have been there and active for 20 consecutive years). He served as the Commander of DelVets Post 2 from 2000-2002. His father Ralph D Knotts Jr. served as Commander of DelVets Post 2 from 1962-1963. John's contributions to the Post and the Community were numerous in helping Veterans in need and established a great relationship between DCVA, DelVets, and numerous community organizations advocating for Service Members and Veterans. He was a great mentor to many Veterans and very passionate about assisting veterans.

Wilmington - Charles Thomas Armbruster, Jr., age 70, died peacefully on June 25, 2019. He was born in Scranton, PA in 1949 to Margaret (Gallagher) and Charles Armbruster. Chuck was very active in the community; American Legion Post 18, Sons of the American Legion Squadron 18, VFW Post 5447, Vietnam Veterans and Del Vets Post 1. He was the State Commander of the American Legion in 1998 - 99 and was currently serving as a member of the Governor's Commission of Veterans Affairs. He was also active in Brandywine Little League, the Romeo Club and Crestview Pool. Several of Chuck's favorite legion programs were American Legion baseball, Boy's State and The Oratorical Program.





The Friends of Delaware Veterans, Inc., a 501c3 and the official fundraising organization of the Veterans Trust Fund, has created a foundation to build a self-sustaining endowment for the Trust Fund.

Twenty-five individuals and organizations contributed a total of \$25,000 to begin the drive with the Delaware Community Foundation managing the fund. The effort was initiated by Friends board member Charles "Chuck" Baldwin who worked with contributors to raise the initial amount to establish the fund and create an ongoing source of revenue that will ultimately provide emergency financial grants to Delaware veterans.

"This effort is in addition to the Friends ongoing work of raising money for the Trust Fund," said board President Dave Skocik. The Friends board, all veterans, volunteer their time and effort and work in conjunction with the Commission of Veterans Affairs. #### WWII veteran and wife contribute to the Veterans Trust Fund

DOVER -- WWII Veteran and former Prisoner of War William "Bill" Willis and his wife Betty have reached out to veterans of succeeding generations by contributing \$15,000 to the Delaware Veterans Trust Fund.

Mr. Willis was shot down over Holland in February 1945 and held captive by German forces until April 1945 before being liberated and will never forget the sacrifices of veterans of all generations.

The Trust Fund is administered by the Commission of Veterans Affairs and makes one time hand up grants to Delaware veterans in demonstrated financial difficulties. Contributions are tax deductible. Signed into law in 2013, the fund has stopped cutoff of utilities, paid for emergency repairs on homes and auto, prevented repossessions, and sometimes puts food on the table.



"It's heartening to accept this contribution from a member of The Greatest Generation to assist our current veterans who find themselves challenged by financial emergencies," said Dave Skocik, president of the Friends of Delaware Veterans. The Friends board is made up of veterans who work as volunteers throughout the year to raise money for the Trust Fund.

#### VA hosts Veterans Town Hall at Walter Fox Post in Dover

DOVER -- Leaders from the Wilmington Veterans Administration Medical Center held a Veterans Town Hall meeting at the American Legion's Walter L. Fox Post, Dover on May 6.

The team, led by VAMC Director Vince Kane, reviewed the efforts of the VA locally, regionally, and nationally to work with veterans to provide outstanding health care services tailored to those who have served. Updates on existing and planned expansion of services in all three counties were provided, including the planned move of the Kent County CBOC (Community Based Outreach Clinic) to the Blue Hen Corporate Center in Dover, which will provide nearly 30,000 sq. ft. of space.

The meeting included Dover Mayor Robin Christiansen who was recognized for his previous and ongoing work with the Delaware Commission of Veterans Affairs on veteran homelessness and sui-



cide prevention. Charles Parisan, First Vice Commander, Walter L. Fox Post 2, was presented a certificate of appreciation for hosting the event that included coffee and snacks along with information tables of available services.

"Veterans are grateful for this level of information and service brought to them in multiple venues," said Dave Skocik, president of the Delaware Veterans Coalition. "The purpose of the meeting was twofold: to educate veterans about the increasing levels of service and care available to them, and to hear feedback about ways to improve what they offer to their fellow veterans." Additional regularly scheduled meetings in each county are planned.

#### **D-Day Tribute and recognition of a hero**

DOVER -- WWII veteran William "Bill" Willis of Dover was honored on June 6 by a House of Representatives tribute commemorating the 75th anniversary of the D-Day landings in France. Setting the tone for the ceremony, multiple representatives rose in turn from their seats, reading portions of President Roosevelt's D-Day prayer.

Mr. Willis was seated beside House Speaker Peter Schwartzkopf during the session. A nose turret gunner in a B-24 Liberator, Mr. Willis was shot down in February 1945 over Holland and spent two months as a German prisoner of war before being liberated in April 1945.

After being introduced to the assembled delegates by Dave Skocik, president of the Delaware Veterans Coalition, the 94-year-old veteran received a prolonged standing ovation.

#### **Pearl Center Veterans Home is Turning 1**

The Pearl Center is a community style home in Wilmington, Delaware with more than 50 apartments for veterans of all kinds. This September 2019 marks a year of establishing veterans in need with a sense of freedom and safety, and connecting them to resources that enhance their quality of life.

Within the first 3 months of opening, The Pearl was completely leased out in December. 40 of the 51 apartments are subsidized via Project-Based HUD-VASH vouchers. Resident amenities include 24-hour emergency maintenance, supportive services programs, a community lounge and easy access to public transit.

The service doesn't stop here, The Pearl's new RV, funded by a grant from the Longwood Foundation, has set up weekly trips throughout New Castle and Kent counties in search of unsheltered homeless Veterans. The Pearl is managed by

A matter of time: Watchmaker Initiative provides skilled training for disabled veterans

ODESSA — The 45-minute graduation ceremony was nearly done Friday when Jonathan Dunn's muted phone buzzed. The Smyrna resident answered shortly afterward and received a job offer to repair watches. His time in the Veterans Watchmaker Initiative was already providing career possibilities. "It's the hardest thing I've ever done but well beyond worth it," said the former Coast Guard member, who was joined by his wife and two children not yet old enough for school. Three other veterans smiled brightly too after receiving diplomas from the only technical school of its kind nationally supporting honorably discharged veterans. There's a nationwide shortage of mechanical watch specialists, so quickly finding employment seem likely. "I'm going to begin a job search," Gumboro resident and Army veteran Jason Adams said. "I could see myself going to New York City or any other number of places."

Program founder Sam Cannan and Swiss-trained watchmaker doggedly worked for seven years to start the school to assist disabled veterans who have an 83 percent unemployment rate. Wife Pauline was with him every step and described as "the backbone of the operation" during closing remarks before approximately 80 onlookers. Attempts to use sites in Kenton and Middletown failed before New Castle County Council and then executive Tom Gordon donated the 3.7 acre property and commercial. Of Cannan, emcee Dave Skocik said "He just kept pushing forward and wouldn't take no for an answer. He was very specific about what he wanted." Mr. Cannan described the experience as a "long, long road" to seeing the fruition of his and others efforts. Joining the veteran graduates were Ellendale resident Giancarlo LoRusso (Marine Corps) and Dover resident Don Morton (USAF) Mr. Morton plans to remain in the program to teach the incoming class his trade, and the dream is to eventually have 50 students in the program. "The last 17 months was a lot of work but very enjoyable at the same time," Mr. Morton said. "It was all about meeting challenges, developing skills, making contacts and being introduced to the world that is watchmaking." With no interest in city living and desiring to stay close to home, Mr. Stanton pictures himself at a nearby watch repair service center fixing Bulova products and other brands. "From beginning to end it was an incredible experience," he said.


